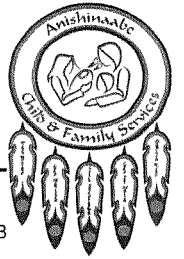

GENERAL RESPONSIBILITIES:

Under the direct supervision of the Regional Program Manager the Supervisor will be part of the Management Team.

QUALIFICATIONS/REQUIREMENTS:

- Bachelor of Social Work degree or equivalent combination of related education and experience.
- A minimum of five years experience in child welfare.
- A minimum of one year supervisory experience.
- Must possess excellent leadership skills.
- Must have a good understanding of First Nations traditions and culture.
- Demonstrated ability to supervise staff with caseloads requiring experience in Intake, Abuse and Family Service.
- Excellent assessment skills, children's behaviour management skills and sound knowledge of separation and attachment issues.
