Education for Reconciliation

Reconciliation in Canada requires more than symbolic gestures, but concrete action to end systemic discrimination and make sure First Nations children and families are treated fairly. Drawing on the Shannen's Dream, Jordan's Principle and "I am a witness" campaigns, Jennifer King will discuss creative ways to engage children and youth in meaningful reconciliation activities. Jordan's Principle, 10th Anniversary

Jordan's Principle ensures that First Nations children and youth receive the same public services as all other young people in the country. This year marks 10 years since Jordan's Principle was unanimously passed in the House of Commons and one year since the Canadian Human Rights Tribunal (Tribunal) ordered the federal government to fully implement Jordan's Principle. Dr. Blackstock will provide an overview of the Tribunal's legal orders and discuss how community members and professionals can ensure all First Nations children, on and off reserve, receive proper benefit from Jordan's Principle.
